

**VILLAGE OF DAVIS
BOARD MEETING MINUTES OF
12-9-25**

The meeting was brought to order by President Olson at 7:00 PM in the Village Municipal Building. Roll was taken with the following present: Mike Wise, Greg Price, Judy LaFurge, Brittney Kunz, Becky Wise, Jodie Pieper, Chelsey Scheid, and Kim Satness, all were present. The Pledge of Allegiance was recited and the Consent Agenda consisting of the November meeting minutes, Treasurer's Report, bills to be paid, and the late utility list was reviewed. Greg made a motion to approve the Consent Agenda and Judy seconded – passed.

Steve reported that discussion is ongoing regarding possibly hiring an Ordinance Officer to be shared with Rock City and Dakota. The salary would be shared between the villages and with the county hiring more officers, there may be some individuals interested in the position.

The 2026 meeting schedule was discussed. It was decided that the meetings would remain on the second Tuesday of each month. This would make the meetings held on 1/13, 2/10, 3/10, 4/14, 5/12, 6/9, 7/14, 8/11, 9/8, 10/13, 11/10, and 12/8. Mike made a motion to approve the schedule and Becky seconded – carried.

Zoning

Steve met with Fehr Graham and was given some sample ordinances from Lena and Monroe to use as a guide when working with the zoning ordinance updates. They gave a proposal of \$10,000.00 (high limit) for time and material for the zoning ordinance. Mike moved to accept the proposal and Brittney seconded – carried.

Water/Sewer

Work on the water project is expected to begin in March. It was advised that an increase of \$5.00 should be considered and will be discussed in January.
