VILLAGE OF DAVIS BOARD MEETING MINUTES OF OCTOBER 14, 2025

President Olson called the meeting to order at 7:00 PM in the Municipal Building. Roll call was taken with the following members present: Greg Price, Judy LaFurge, Kim Satness, Becky Wise, and Jodie Pieper. Mike Wise, Brittney Kunz, and Chelsey Scheid were not present. The Pledge of Allegiance was recited and business began.

The Consent Agenda was reviewed and the only change was the Helm Group invoice payment is to be paid from the water fund instead of the general fund. Judy made a motion to approve the consent agenda and Jodie seconded the motion – carried.

Margo Turman was present and expressed concern for some fence posts by the cemetery area. She suggested this may cause problems and should either be marked better or removed or possibly a fence should be put there. A motion was made by Greg to have Ray removed the posts and check for prices for landscaping and trees. Becky seconded the motion and it carried.

Robert Wyss was present and had concerns about the village truck not stopping at stop signs correctly. Steve will speak to Ray to correct this issue. Robert also said there is water running across his driveway from drainage off of Ed Koelling's property where his shed was built.

Steve said that the updated ordinance book is ready after the several changes were made including details involving the water rates, the odd/even for snow parking, and games of chance. Vote was called to approve the new Updated Ordinance Book and it passed with 100% roll call.

There is a possible date set to talk with Rock City officials regarding hiring and sharing a Code Enforcement Officer.

Steve had some recommendations from Rich Rote about adding utility buildings to the building permits and also the issue about business being run in homes zoned as residential. Now that the general ordinance book is completed, work will begin on updating the zoning ordinance book.
